“RESOLUTION ADOPTING REPUBLIC ACT NO. 11469 “THE BAYANIHAN TO HEAL AS ONE ACT,” SECTION 4(Z) MOVE STATUTORY DEADLINES AND TIMELINESS FOR THE FILING AND SUBMISSION OF ANY DOCUMENT, THE PAYMENT OF TAXES, FEES AND OTHER CHARGES REQUIRED BY LAW, AND THE GRANT OF ANY BENEFIT, IN ORDER TO EASE THE BURDEN ON INDIVIDUALS UNDER COMMUNITY QUARANTINE”

WHEREAS, with the continuing rise of confirmed cases of COVID-19 in the Philippines, the serious threat to health, safety, security and lives of our countrymen, the President of the Philippines has approved on March 24, 2020, Republic Act (RA) 11469, “An Act Declaring the existence of a National Emergency arising from the Coronavirus Disease 2019 (COVID-19) situation and a National Policy in connection therewith, and authorizing the President of the Republic of the Philippines for a limited period and subject to restrictions, to exercise powers necessary and proper to carry out the declared national policy and for other purposes”, otherwise known as the “the Bayanihan to Heal as one Act”;

WHEREAS, Section 4(z) of RA 11469 specifically provides that, "Move statutory deadlines and timeliness for the filing and submission of any document, the payment of taxes, fees and other charges required by law, and the grant of any benefit, in order to ease the burden on individuals under Community Quarantine".

WHEREAS, pursuant thereto, the Office of the City Treasurer will be implementing the following course of action:

- Due date for the 1st quarter payment of business tax shall be moved from April 20, 2020 to May 20, 2020 without adding surcharge and interest;
- 2 % interest per month for the Real Property Tax shall not be imposed;
- Tax Amnesty Program will be extended from June 31, 2020 to Dec. 31, 2020;

WHEREAS, recognizing the significance of the said Act in promoting the welfare of the city's constituents and to expedite the combat against COVID-19, the Sangguniang Panlungsod finds it appropriate to adopt RA 11469 specifically section 4(z) and the guidelines set by the City Treasurer's Office;

NOW THEREFORE, BE IT-

RESOLVED AS IT IS HEREBY RESOLVED, to adopt Republic Act No. 11469 "The Bayanihan to Heal as One Act," Section 4(z) move statutory deadlines and timeliness for the filing and submission of any document, the payment of taxes, fees and other charges required by law, and the grant of any benefit, in order to ease the burden on individuals under Community Quarantine.

RESOLVED FINALLY, to furnish copies of this resolution to all concerned offices/parties for their information and appropriate action on this matter.
