EXECUTIVE ORDER NO. 30-A

Series of 2020

“AN ORDER PROVIDING FOR ADDITIONAL GUIDELINES OF EXECUTIVE ORDER NO. 30 PLACING BISLIG CITY UNDER GENERAL COMMUNITY QUARANTINE (GCQ).”

WHEREAS, the World Health Organization declared a pandemic on the spread of Covid-19 infection;

WHEREAS, President Rodrigo R. Duterte issued Presidential Proclamation No. 922 placing the country in a State of Public Health Emergency and Presidential Proclamation No. 929 declaring a State of Calamity in the entire country for a period of six (6) months;

WHEREAS, the Land Transportation Franchising and Regulatory Board (LTFRB) issued Regional Office Circular No. 2020-18 regarding various rationalized routes opened for GCQ areas in Caraga. Hence, strict implementation of certain health procedures on public transportation is highly needed;

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code provides that within their respective territorial jurisdiction, local government units shall ensure and promote health and safety of their inhabitants;

WHEREAS, Article 87 of the Rules and Regulations Implementing the Local Government Code of 1991 has specified the powers, duties and functions of the City Mayor aimed at promoting the general welfare of the city and its inhabitants necessitate the enforcement of community quarantine of the entire city to contain the transmission of corona virus among its residents and prescribing rules and regulations and sanctions against violation thereof.

NOW, THEREFORE, I FLORENCIO C. GARAY, City Mayor of Bislig City, Surigao del Sur, by virtue of the power vested in me by law, do hereby order the following during the duration of the General Community Quarantine, to wit:

SECTION 1. Additional Guidelines. The following are the additional guidelines in the implementation of the General Community Quarantine, to wit:

A. **Bus and Van operators** are strictly mandated to observe certain health standards at all loading points and inside the vehicle, namely:

1. Mandatory wearing of face mask.
2. Social distancing of not less than one (1) meter.
3. No touch policy shall be strictly implemented.
4. Mandatory use of alcohol or hand sanitizers.
5. Mandatory use of thermal scanner.
6. Mandatory disinfecting procedures of vehicles.
7. Medical certificate of driver and conductor.

8. Medical certificate of passengers.
- B. All residents entering Bislig City who travelled from places with or without confirmed cases of COVID-19 shall undergo **mandatory quarantine**, except those who are considered front liners.
- C. Home quarantine for fourteen (14) days shall be imposed to Persons Under Monitoring (PUM); meaning those without symptoms. However, quarantine at an isolation area for fourteen (14) days is required for Persons Under Investigation (PUI); meaning those with mild symptoms.
- D. The implementation of **City Ordinance No. 2008-11 otherwise known as the Fare Matrix Ordinance shall be temporarily suspended** during the duration of the GCQ.
- E. In compliance with the one (1) meter social distancing and considering that public transportation is already resumed, **back riding is no longer allowed to all single motorcycle.**

SECTION 2. Special Penalties. The following penalties shall be imposed to persons who are found to have violated the **curfew, passenger limit on transportation, mandatory wearing of face mask, mandatory quarantine and failure to carry necessary pass**, to wit:


- First offense – a fine of **P500.00**
- Second offense – a fine of **P1,000.00**
- Third offense – a fine of **P2,000.00**

SECTION 3. Separability Clause. In the event that any provision in this Order or any part hereof is declared invalid, illegal, or unconstitutional, the provisions not hereby affected shall remain in force and in effect.

SECTION 4. Repealing Clause. All orders, rules and regulations, other issuances, or parts hereof which are inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

SECTION 5. Effectivity. This Executive Order shall take effect at **12:01 a.m. of**
06 MAY 2020 2020 and shall remain in force unless sooner revoked or amended.
