EXECUTIVE ORDER NO. 47-A

Series of 2020

**AN ORDER PROVIDING FOR ADDITIONAL AREAS TO BE COVERED
BY THE 7-DAY LOCKDOWN UNDER EXECUTIVE ORDER NO. 47**

WHEREAS, under Section 15, Article II of the Philippine Constitution, it is the policy of the State to protect and promote the right to health of the people;

WHEREAS, President Rodrigo R. Duterte issued Presidential Proclamation No. 922 placing the country in a State of Public Health Emergency;

WHEREAS, a vendor from meat section of Bislig City Central Public Market, Mangagoy, Bislig City died due to Covid-19 on September 2, 2020 and had been reportedly exposed to other people in the area;

WHEREAS, by virtue of E.O. No. 46, s. of 2020, Mayor Florencio C. Garay placed the Bislig City Central Public Market (BCCPM) under a 5-day lockdown;

WHEREAS, the City Government of Bislig conducted disease surveillance, contact tracing and rapid testing of all market vendors of BCCPM and other suspected persons who might have contact with the market vendor who died of COVID-19;

WHEREAS, as of September 10, 2020, out of the 195 individuals who have undergone rapid testing, 114 tested positive. The City Health Office is still on the continuous process of contact tracing and rapid testing; hence, the said figures may still go up;

WHEREAS, other areas/sections under CEEDO management also require disease surveillance, contact tracing and rapid testing; hence, must be included in the 7-day lockdown;

WHEREAS, Section 3(n) of R.A. 11332 defines response as the implementation of specific activities to control further spread of infections, outbreaks or epidemics and prevent re-occurrence. It includes verification and rapid risk assessment activities, among others;

WHEREAS, under Section 455 (b)(1)(vii) of the Local Government Code (LGC), the City Mayor is empowered to carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities;

WHEREAS, there is an urgent need for the LGU of Bislig City to act promptly in providing health and safety measures in the interest of public health;

NOW, THEREFORE, I FLORENCIO C. GARAY, City Mayor of Bislig City, Surigao del Sur, by virtue of the power vested in me by law, do hereby order a 7-day lockdown for purposes of disease surveillance, contact tracing and rapid testing as the City's response measures to the imminent danger imposed by Covid-19.

SECTION 1. Additional Areas. The following areas shall be included in the 7-day lockdown, to wit:


1. Dry goods section;
2. Eatery section;
3. Sari-sari section;
4. Tricycle and jeepney terminal;
5. *Ukay-ukay* section;
6. Marine section;
7. Livestock section; and
8. Others that are under CEEDO management.

SECTION 2. Separability Clause. In the event that any provision in this Order or any part hereof is declared invalid, illegal, or unconstitutional, the provisions not affected thereby shall remain in force and in effect.

SECTION 3. Repealing Clause. All orders, rules and regulations, other issuances, or parts hereof which are inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

SECTION 4. Effectivity. This Executive Order shall take effect from 5:00AM of September 11 to 5:00 AM of September 18, 2020.
