Brief Description

- : A. Removal of existing dilapidated CHB Canal, Roadway & structure excavation, foundation fill, embankment, const. of 166.05 sq.m x 0.15m thk. Road on prepared base and construction of 81 L.m concrete drainage canal with cover & curb.
- B. Roadway and structure excavation, foundation fill, aggregate base course and construction of 81 L.m concrete canal with cover/ walkway & curb and concreting of 24.30 sq.m x 0.15 m thk. Concrete gutter.
- C. Removal of Structure and obstruction, excavation, embankment, foundation fill and const. of 27.80 L.m. stone masonry riprap canal with concrete pouring @ 0.05 m thk. At top and construction of concrete footbridge / slab for Jetmatic pump.
- D. Removal of existing concrete pavement, roadway & structure excavation, foundation fill and construction of 20 sq.m x 0.20m thk. Road on a gravel base and construction of 20 L.m. concrete canal with cover and curb.
