Brief Description :

Clearing & Demolition, Structure Excavation, Embankment, Backfilling and Gravel Bedding, Reinforced concrete of Footing and column, Beam, Roof beam, Lintel beam, Corbel, Countertop and Flooring with tiles. Construction of indoor ramp and stair with railing, rough-in Installation of Sewer and Water Storage Tank, Pipes and Fittings, Fire Suppression Water System, Installation of Air-conditioning units, Installation of Service elevator, Power house/room. Construction of painted steel roof framing, Installation of roof and wall flashing, Installation of 4" thk. and 6" thk CHB wall with finishing.

Prospective bidders should have completed a similar project over the last 5 years from the date of Bid Submission both in Design and Construction with at least 50% of the cost of the ABC of the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted. In the event that the Design and Construction shall be accomplished separately by the parties in JVA, sub-Contracting or Partnerships, as the case may be, the party that will accomplish the design should have at least one similar project, the cost of which is equivalent to at least 50% of the 3% of the ABC, while the party tasked to accomplish the construction component, should have at least one similar project, the cost of which is equivalent to at least 50% of the ABC.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post-qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulation (IRR).
